## Sex-abuse sentences overturned

Two Bakersfield, Calif., couples will be freed from prison after 14 years of a combined 1,000-year sentence because their convictions on child sex-abuse charges were overturned, and prosecutors will not retry them. Kern County Judge Jon Stuebbe said testimony in the trial of Scott and Brenda Kniffen and Alvin and Deborah McCuan was unreliable because authorities used "unacceptably suggestive" techniques in repeatedly asking the children leading questions over many months. Two of the children later said no abuse occurred. Critics say children often are coerced into making accusations by overzealous authorities.
