DOZIER OPENED THE PASSENGER DOOR AND WAS IN CONTACT WITH THE CADILLAC "BEFORE" THE CRASH. DOZIER "LIED," AND DID NOT CALL 911. DOZIER'S CAR WAS DAMAGED WHEN IT RAN THE CADILLAC OFF THE ROAD. ALTHOUGH THERE WAS AN ARREST WARRANT FOR DOZIER, FOOHILL DETECTIVE FISK DID NOT ARREST DOZIER.

Investigator Tony Cota - TC:

Schwab and Fisk's felon-informant, John Dozier - JD:

TC: The doors were closed?

JD: Yeah. Both doors were closed.

TC: Did you open up the door?

JD: Yeah, both - - -

TC: Did you leave the "doors" open when you left?

JD: Uh-uh

TJ: Did you close the door back-up?

JD: I might have left "them" open, man, you know, like, I told you - you know, I was ah - I had been drinking that night. You know, so I could have left the door open, you know, it's possible.

TC: How about the door on the "passenger" side? Did you "open" that up to try to get - -

JD: I opened "both" of them, yeah, cause I tried to get them "both" out. And I couldn't get them out and I called 911. Eventually they came. It took so long.

THIS "EXPOSED" THAT DOZIER WAS "IN CONTACT" WITH THE CADILLAC, AND CLAIRE AND NATASHA, BEFORE THE CRASH. AFTER THE CRASH THE PASSENGER DOOR HAD TO BE PRIED OPEN. DOZIER, AT TRIAL, TESTIFIED HE WAS "NOT" DRUNK, AND WAS CLEAR HEADED. DOZIER TESTIFIED, IN ELABORATE DETAIL, THAT HE USED THE "ELECTRIC SEAT" BUTTON TO MOVE THE CAR SEAT BACK. AFTER THE CRASH THERE WAS "NO" ELECTRIC POWER FOR THE CAR SEAT BECAUSE THE BATTERY WAS DESTROYED IN THE CRASH AND THIS AGAIN EXPOSED THAT DOZIER WAS IN CONTRACT WITH THE CADILLAC BEFORE THE CRASH.

TC: How much do you weigh sir?

JD: About 190

TC: 190 - 5' 11"?

JD: Yeah.

TC: What's your date of birth?

JD: 11-5-56.

TC: 11-5-56?

TC: where were you born?

JD: Ah - Los Angeles, California.

TC: Now, when you arrived and you saw this white man, the tall heavy set man or big man, what did he say when you arrived there? Did he say anything to you?

JD: Well he, yeah, he said that he called 911, but nobody would come. You know.

TC: OK. Now, was the door open at that time when you arrived?

JD: Yeah. Yeah it was open.

TC: Did he say that he had opened it?

JD: I didn't ask all those questions, no.

TC: But you remember that you had closed it?

JD: No, I said I could have left "them" open.

TC: You could have left "them" open?

JD: Yeah. I said it was possible that I - I probably did. You know.

TC: But you do remember "opening" both doors?

JD: I remember opening "both" doors.

TC: The driver's side and the passenger side?

JD: And the "passenger" side. Like I said, when I came up there wasn't nobody there.

TC: OK.

THIS AGAIN EXPOSED THAT DOZIER WAS IN CONTACT WITH THE CADILLAC BEFORE THE CRASH BECAUSE AFTER THE CRASH THE PASSENGER DOOR HAD TO BE OPENED WITH A CROWBAR. AND DOZIER'S TESTIMONY THAT HE USED THE ELECTRIC CAR SEAT BUTTON TO MOVE BACK THE CADILLAC'S ELECTRIC SEAT AGAIN EXPOSED THAT DOZIER WAS IN CONTACT WITH CLAIRE AND NATASHA BEFORE THE CRASH. CORRUPT SCHWAB AND RICHMAN KNEW THIS EXPOSED THAT THEIR ACCOMPLICES KILLED CLAIRE, AND A BREAK WAS CALLED AND DOZIER WAS COACHED TO CHANGE HIS TESTIMONY TO COVER UP THEIR MURDER.

JD: When I - when I first came upon the scene of the accident there wasn't no cars there, there wasn't - there wasn't nothing. The reason that I seen the car - cause it was sparking underneath. You know. that's the only reason - really reason why I stopped, you know, cause I though the car was going to blow up, and you know, I - shit, I tried to be a good Samaritan and I - well I stopped to see if I could, you know, ----- you know.

THE ACCIDENT RECONSTRUCTION EXPERT, RALPH ENGDahl, PERFORMED TESTING WHICH ESTABLISHED THAT THE GAS SOAKED ROPE WOULD ONLY "INITIALLY" SPARK FOR A FEW SECONDS WHEN LIT, WHICH OBVIOUSLY MEANT THAT DOZIER "LIT THE ROPE" IF DOZIER SAW SPARKING.

TC: Did you smell anything?

JD: No. It was just like sparking underneath, you know.

TC: Could you smell anything out of the ordinary?

JD: Nothing, but blood.

TC: That's all you could smell?

JD: Yeah. That's - it was full of blood.

TC: Both bodies?

JD: Yeah. both of them, they was, I mean, you know; they was full of blood, you know.

TC: All over their face?

JD: All over everywhere.

WITNESS CHARLES LANE SAW, WITH HIS FACE ONLY "12 INCHES" FROM CLAIRE'S FACE, THAT CLAIRE HAD NO INJURIES AND NO BLOOD ON HER AFTER THE CRASH, AND THAT DOZIER (BEFORE 4:00 A.M.) ALSO HAD NO BLOOD ON HIM. WITNESS BOBBY ADAMS ALSO SAW THAT CLAIRE HAD NO INJURIES AND WAS ALIVE AFTER THE CRASH, AND SAW THAT DOZIER WITH NELSON WAS TIEING A ROPE UNDER THE CADILLAC, WHICH WAS LATER FOUND TO BE BURNING. THESE, AND ALL OTHER WITNESSES WERE HARASSED AND HAD ALL KINDS OF PRESSURE (INCLUDING MURDER) BROUGHT AGAINST THEM BY SCHWAB, RICHMAN, FISK, GREEN, AND THEIR ACCOMPLICES TO FORCE THEM TO CHANGE WHAT THEY WITNESSED, SO SCHWAB, AND HIS RACKETEERING GROUP, COULD COVER UP THEIR MURDER OF CLAIRE TO FRAME R. PEERNOCK.

TC: And all over their clothes too.

JD: Everywhere. They was full of blood.

TC: Now how about the ah - could you smell gasoline?

JD: Shoot. No, I don't know. I can't remember, you know, all of them details like that.

TC: You can't remember if there was a strong smell of gasoline?

JD: No, I can't remember. You know, like I said, you know, I was kind of ruined.

TC: You had been drinking?

JD: Yeah, I was kind of bent.

SCHWAB'S INFORMANT'S (DOZIER'S) SWORN TESTIMONY
--AT SCHWAB'S ILLEGAL, RIGGED TRIAL-- WAS THAT HE WAS "NOT DRUNK"; ADMITTING THAT WHAT HE TOLD INVESTIGATOR TONY COTA WAS A "LIE" IN AN ATTEMPT TO COVER UP THEIR MURDER AND THEIR SABOTAGE OF THE CADILLAC AFTER THEY FORCED CLAIRE'S CAR OFF THE ROAD INTO THE POLE.

TC: OK. Ah, who else was there besides that white heavy set man, the big man?

JD: Oh shit, it wasn't my car, it was my sister's car at the time.

TC: What color was it?

JD: White and blue.

TC: Mostly white or?

JD: The outside was all white. The inside was blue.

TC: It was blue on the inside and the outside was white?

JD: Yeah. You know, I don't understand this. Cause, you know, you know, I went down to Foothill Police and everything, and they took "another" statement. The Police also "took a statement from me that night," you know. I don't - I don't understand why you all can't get copies of it - I mean, you know.

IN VIOLATION OF "BRADY" AND THE LAW, CORRUPT JUDGE SCHWAB CONSPIRED WITH RICHMAN, FISK, AND HIS BRIBED DEFENSE ATTORNEY, GREEN, TO WITHHOLD AND HIDE THE STATEMENTS BY SCHWAB'S INFORMANT, DOZIER. THESE STATEMENTS "EXPOSED" THAT SCHWAB'S INFORMANT KILLED CLAIRE. TC: Well, just the process of elimination. checked all the - all the Phillipe ah Avenues out here in this area - figured you had to live out here, you know, nearby the vicinity. Now how about ah - it's taken me a few days to do it, but - -

Now how about ah - you gave them an address of 890-1413. Do you know - where does that phone go to?

JD: Oh, that use to be the phone here.

TC: Did you see a truck?

JD: There was on there with big lights, yeah. But he wasn't like - well you know there wasn't no traffic on the street. It was like -

TC: Well to keep other cars from hitting it - that's what I mean.

JD: Shit, wasn't nobody gonna hit that - hit the Eldorado. It was way up on the pole.

TC: Was it?

JD: Yeah. Wasn't nobody gonna hit it. It wasn't - it wasn't to stop

nobody from hitting it. You know. Let me tell you I wouldn't seen the car, cause the car was black on black.

TC: How did you happen to see it you just saw some sparks coming for the underside, but you can't tell where they were coming from?

JD: No, I couldn't tell where it was coming from.

TC: How long after you got there the second time did, ah - did ah the Police arrive?

JD: They arrived in, about - after I called twice, they arrived in about thirty minutes

TC: You called twice?

JD: Yeah, I called twice.

TC: In how long a period?

JD: About fifteen minutes apart.

TC: Fifteen minutes apart, and it was a half hour later from the first time?

JD: Oh yeah. It took them a while.

TC: And who arrived first, the Police or the ambulance?

JD: Shit. I think the Fire Department came first. And then the ambulance - - - - - Yeah, man. Shit, shit I don't know - - - - - , you know

TC: Did you know any of the two women?

JD: Shit no. I didn't know them. No, I didn't know them.

DOZIER--WHO WAS WORKING FOR FISK, SCHWAB AND DOOM--WITH HIS SISTER, CHARMINE, WAS SUPPLYING DRUGS TO NATASHA. SEE CLAIRE'S LAST LETTER, WHICH WAS HIDDEN BY CORRUPT JUDGE SCHWAB, AND HIS CORRUPT BUDDY JUDGES, TO OBSTRUCT JUSTICE AND TO COVER UP THEIR RACKETEERING SCAM.

IN UNEQUIVOCAL VIOLATION OF THE LAW, FISK, SCHWAB, AND EACH OF THEIR BRIBED DEFENSE ATTORNEYS, WITHHELD AND HID THE STATEMENTS BY FELON DOZIER BECAUSE THE "STATEMENTS" EXPOSED THAT HE KILLED CLAIRE. FISK ALSO TRIED TO KEEP SECRET "WHO DOZIER WAS," AND THAT DOZIER WAS THEIR ENFORCER, AND FISK FALSIFIED THE POLICE REPORTS IN HIS ATTEMPTS TO KEEP DOZIER'S IDENTITY AND ADDRESS A SECRET. AND SCHWAB, DURING HIS ILLEGAL, RIGGED TRIAL, KEPT SECRET FROM THE JURY DOZIER'S EXTENSIVE CRIMINAL RECORD, AND THAT DOZIER WAS AT A PREVIOUS "SIMILAR" TYPE MURDER SET-UP BY THE COPS.

TC: Were not - I'm not the policeman.

JD: Yeah I know, but see I don't even know who you is. I mean you - you -

TC: I told you I'm a private investigator.

JD: Yeah. You didn't show me no - you know, no identification or nothing. You could be anybody.

TC: Here is my identification. I told you who I was. I'm representing Mr. Peernock, the man who was arrested.

JD: The man who was arrested. OK. Shit, you know. I mean, I ain't trying to be smart or nothing, but I mean, you know, you could be anybody.

TC: I understand. But I'm questioning the ah - the method that they used.

JD: Shit.

TC: That they didn't - that they didn't get a complete report from you.

JD: They got a complete report. I'm telling you I went down to Foothill - -

TC: And then six months later they come around and get another one.

CD: How you think the woman, you know- - was killed.

JD: She was - - her head was like all caved in, you know. And they said don't worry about the woman, and we don't care anything about your warrants. We need a statement. You come down and we guarantee we won't arrest you. - - You know, I was there for about "3 hours," so they asked me, well, did you see a station wagon there. "No," there was no car there.

TC: Was the woman seated down below the seat or was she on the seat?

JR: She was off the seat. Both of them was off the seat.

TC: Down on the floorboard?

JD: Down on the floorboard.

TC: Did she have her knees up underneath the dashboard?

JD: Yeah.

FISK DID NOT ARREST THEIR INFORMANT AND ENFORCER, DOZIER, AT THE MURDER SCENE ALTHOUGH DOZIER HAD AN EXTENSIVE CRIMINAL RECORD, AND HAD MANY ASSAULTS ON WOMEN AND WAS COVERED WITH WET-FLUID BLOOD WHEN THE PARAMEDICS ARRIVED AT 4:38 A.M. AND ALTHOUGH NATASHA'S STATEMENTS WERE THAT THEY "MET SOME GUYS" AFTER THEY LEFT THEIR HOUSE AT 10:30 P.M. AND ALTHOUGH WITNESS CHARLES LANE SAW THAT CLAIRE HAD NO INJURIES AND NO BLOOD ON HER, AND THAT DOZIER HAD NO BLOOD ON HIM "BEFORE" 4:00 A.M. AND WAS THEN COVERED WITH WET-FLUID BLOOD AT 4:38 A.M., AND ALTHOUGH FISK KNEW BLOOD COAGULATES IN 10 - 15 MINUTES. AND ALTHOUGH THERE WERE ARREST WARRANTS FOR DOZIER AND DOZIER'S CAR WAS DAMAGED WHEN IT CUT OFF THE CADILLAC, FISK INSTEAD STOPPED ALL THE OTHER POLICE OFFICERS, AT THE MURDER SCENE, FROM SEARCHING DOZIER'S CAR FOR THE MURDER WEAPON, AND TOLD DOZIER TO LEAVE THE SCENE. THIS WAS EVEN THOUGH THE "911 CALL" CAME IN AS AN ASSAULT ON WOMEN BY A BLACKMAN. FISK ALSO HAD HIS BUDDY DETECTIVES "GUARANTEE" THAT THEY WOULD NOT ARREST AND CHARGE DOZIER FOR THIS UNEQUIVOCALLY OBVIOUS MURDER, BUT INSTEAD CONSPIRE TO FRAME R. PEERNOCK, WHO WAS "NOT" AT THE SCENE AT ANY TIME, AND WAS "24 MILES AWAY."
