

SCHWAB'S INFORMANT, DOZIER, IDENTIFIES DENNIS NELSON'S PHOTO AND ADMITS THAT DENNIS NELSON WAS AT THE SCENE [AS ESTABLISHED BY OTHER WITNESSES AND NELSON'S OWN TESTIMONY]. Schwab and Fisk's felon-informant, John Dozier - JD:

WJ: I know I showed you these pictures before, It is my obligation to show them to you again.

JD: - - - -

WJ: And see if you recognize this as the man who was there?

JD: It could have been him, yes - - -

INVESTIGATOR JUDD SHOWED DOZIER PHOTOS OF DENNIS NELSON WHO WAS ALREADY IDENTIFIED AND ESTABLISHED AS BEING AT THE SCENE, AND DOZIER RELUCTANTLY ADMITS THAT DENNIS NELSON WAS THERE.

WJ: He has been identified as having been there and these questions that are asked of you are on the tape, and your truthful answers as you recall them to be.

JD: Yes

WJ: Now, somewhere on the tape you said there was a young man in a truck with "big lights" who stopped. Do you recall that part?

JD: Yes.

THIS WAS WITNESS BOBBY ADAMS WITH THE "BIG LIGHTS," WHO SCHWAB, FISK AND DOOM REPEATEDLY TRIED TO HAVE THE COPS "KILL," TO PREVENT HIS TESTIMONY. AND SCHWAB, IN CONSPIRACY WITH PROSECUTOR RICHMAN, WITHHELD AND HID THE TAPED INTERVIEW BY RICHMAN, AND FISK'S DETECTIVE BUDDIES, DURING WHICH DEATH THREATS AND BRIBES WERE OFFERED, INCLUDING RELEASE FROM THEIR FRAME-UP AND ILLEGAL, FALSE

IMPRISONMENT, IF ADAMS WOULD COMMIT PERJURY FOR THEM AND CLAIM HE DIDN'T SEE ANYTHING, AND TO HELP THEM COVER UP THEIR MURDER AND FALSELY IMPRISON R. PEERNOCK. AND TO OBSTRUCT JUSTICE, AND COVER UP THEIR MURDER, JUDGE SCHWAB CONSPIRED WITH RICHMAN AND GREEN TO "NOT ALLOW" ADAMS TO TESTIFY BECAUSE HE REFUSED THEIR BRIBES AND WOULDN'T COMMIT PERJURY FOR THEM. WJ: You will cooperate, when you get a subpoena, you will cooperate

JD: Yeah, but I don't want to get involved - - - I mean - -

WJ: I'm not sure just how they will use what you have to say - -

JD: I don't either, because, you know, mainly because the husband,

WJ: What?

JD: The woman who died, her husband

WJ: Yes?

JD: - - he wasn't there when I got there - - -

WJ: OK, well, thank you, for your help, I appreciate it.

DOZIER "CONFIRMED"--BECAUSE OF HIS PRIOR ADMISSIONS DURING TAPED RECORDED INTERVIEWS--THAT ROBERT PEERNOCK WAS "NOT" AT THE SCENE AT ANY TIME, ALTHOUGH DOZIER ADMITTED, DURING HIS SWORN TESTIMONY, THAT HE WAS THERE AT THE SCENE FROM 2:00 A.M., AND ALSO ADMITTED, IN TAPE RECORDED STATEMENTS, THAT HE WAS THERE FOR "3 HOURS" BEFORE THE PARAMEDICS ARRIVED AT 4:38 A.M. AND DOZIER ALSO STATED TO WITNESS MARLITZ THAT HE WAS THERE FOR "MORE THAN 45 MINUTES" BEFORE MARLITZ ARRIVED, AND WAS ALSO "SEEN" WITH "NO" BLOOD ON HIM BY WITNESS CHARLES LANE "BEFORE" 4:00 A.M., AND WAS ALSO SEEN, WITH NELSON, "TIEING" THE COTTON ROPE UNDER THE CADILLAC. SCHWAB, TO COVER UP THEIR MURDER AND TO OBSTRUCT JUSTICE, BLOCKED ALL THIS EVIDENCE FROM BEING PRESENTED, SO THEY COULD FRAME R. PEERNOCK FOR "BLOWING THE WHISTLE" ON THEIR ONGOING CORRUPTION.
