- D. He was never there. Bob was never there. (Dogs loudly barking).
My dad's a cop. -----
- A. And another strange thing about a month ago he installed an answering service? (Cota reading from Foothill Police Report)
- C. I don't know anything about that.
(Dogs barking loudly in the background)
- A. You don't remember having said that?
- C. I didn't say that.
- D. He didn't say that. I didn't say that either. Are you sure?
- A. (Cota reading from Police Report). And he is a professional at suing, Did he ever threaten to sue you?
- C. He never threatened to sue me, but he got a little riled about his daughter one day my dog bit her, we got into an argument, but nothing
- A. But nothing happened? (Dogs barking loudly).
- C. No nothing -- happened, he didn't
- A. What kind of car did he have?
- C. A Toyota or Datsun or something, a station wagon.
- A. What color was that?

- C. Blue with a white stripe, I believe
- A. Was it parked on the street?
- C. It was parked on the street
- A. And the Cadillac was backed up into the garage?
- C. Yes, normally the Cadillac was over this way further and covered but he did take it occasionally ----- you know ---- to me it was nothing UNUSUAL.
- A. How long has the Cadillac been parked there previously to -----
- C. I really couldn't tell you, because it was on, and off, and on thing with him. So ---- I came home from work, and the only reason I noticed him at the time is because he yelled at his younger daughter She was doing something and he yelled at her to get away from there or something, I looked over and he happened to be there.
- A. Do you remember what day it was?
- C. Well, I'M NOT EXACT ON THE DAY. I DON'T KNOW whether it was a Monday or the night of the problem, but it was right around that similar time. I couldn't tell exact because I couldn't remember exact.
- A. What time did you get home from work?
- C. Well I got home a little after 5 PM.-- he yelled at her, and that's the only reason I noticed
- A. Which daughter did he yell to?
- C. The young one
- A. Tania
- D. Are you sure?
- C. Not very sure Dawna. I'm not, I'm not --
- D. If your not sure, you should just keep quiet, because you just don't know

- A. The Police say THEY INTERVIEWED YOU ON THE 23 OF JULY
- D. NO BODY INTERVIEW ANY BODY.
