B. Yes.

C. My name is Tony Cota, Mrs. BudSCO. I'm a Private Investigator.
May I speak with you. This is regarding Mr. Peernock.

B. Uh ha, what about?

C. Well it's regarding a statement that you made to the police.
I represent Mr. Peernock.

B. Uh ha.

C. This is, this is in reference to a statement that you made
sometime back on October the 5th. --- I'm sorry --- July 23, 1987

B. Uh ha

C. "I came home Tuesday night between 11:30 and 12:30. I did not
notice anything different. There was no banging or loud noises"?

- B. I think right here I said I DIDN'T NOTICE ANY LOUD NOISES OR ANYTHING, because I said if, you know, if there was something unusual MY DOGS WOULD BE MAKING A LOT OF NOISE. IF SOMETHING THAT WASN'T NORMAL BECAUSE THEY WOULD BARK LIKE BANSHEES.
- C. What kind of dogs do you have?
- B. A Coyote, and a Labrador mix, and a Shepherd mix.
- C. So they're very sensitive. They can really pick-up
- B. She, she barks a lot. WHEN THERE IS PEOPLE AROUND THE NEIGHBORHOOD SHE KNOWS. Because if there, I said, if there was anything going on when I came home, my dogs would be barking and making a lot of noise.
- C. Un ha.
- B. When I came up the driveway, if there was something that was causing a disturbance, they would have been barking.
- C. Did you hear them fighting at any time?
- B. I never heard them fight. I never heard them. People down on the corner fight. I mean we fight. We use to fight.
- C. Is this your correct number?
- B. 27373
- C. 373
- B. It's a little mixed-up ----- YOU SEE, I NEVER SAID THIS, "HE NEVER ALLOWED HER IN IT (THE CADILLAC)". There is NO WAY I would know that. I NEVER SAID THAT. I DIDN'T SAY THAT.

I said IF THERE WAS ANYTHING GOING ON WHEN I CAME HOME THAT MY DOGS WOULD BE BARKING AND MAKING A LOT OF NOISE.
